Your restaurant will need to submit a IRS form 1099 to GRP to receive Monthly Commission payments.
- BOGOmazing Member Order Requirement: A BOGOmazing Member and guest (Party of 2) must purchase 2 Drinks (regular or alcoholic), 1 Select Appetizer (your more expensive selections), 1 Select Entree (your more expensive selections) to then qualify for a menu item of equal or lesser value. Your FREE Menu Selection list will exclude all drinks, appetizers and desserts but would typically include the rest of your menu. BOGOmazing works with a party of 2, 4 or 6 making the purchase requirement double or triple from a party of 2. You are in 100% control of all BOGOMazing Menus that appear on the app.

BOGOmazing Member Order Tracking: You are provided with BOGOmazing Transaction Tracking Software (BTTS) which records all BOGOmazing Transactions tracking back to a single server (if all servers are entered into the BTTS which is your option) that also includes the BOGOmazing Members name, date and time of the transaction. The BTTS allows you to enter in the rest of the BOGOmazing guest ticket data and automatically figures the redemption cost and other metrics for a single and/or multiple BOGOmazing transactions.

BOGOmazing Transaction Tracking Software (BTTS): BTTS is provided for FREE and not only tracks all BOGOmazing transactions and BOGOmazing Membership Referrals down to a single employee, BTTS also has 100% of your restaurant and menu information featured on BOGOmazing presented to the BOGOmazing members. It is the responsibility of the restaurant to keep all restaurant data and menus accurate. Restaurants do not have to enter in any staff information if they do not desire to track transactions and referrals down to a specific employee. GRP will do 100% of your initial set up in BOGOmazing and can make further changes if contacted through the BTTS contact us link.
